Advantage Golf Cars SEFL LLC - Rental Agreement

In consideration for the rental of the golf car(s) provided by Advantage Golf Cars SEFL LLC, I, Colour Republic LLC, agree to the following conditions. In the event that I violate any of the following conditions, I agree and understand that further use of the golf car(s) may be revoked immediately and without notice:

1. I promise to return the golf car(s) upon completion of the rental period in as good condition as I received the same. I will operate the golf car(s) safely and responsibly, and I will preserve and protect the golf car(s) from loss or damage to the car(s) itself, my person or property, and the persons or property of others. I agree and understand failure to comply with the terms of this agreement will result in a forfeiture of my rental fees and deposit. **I agree to be legally and financially liable for all costs of repairs to the golf car(s) and for the loss, damage and/or injuries to my person or property and the persons or property of others regardless of fault.** I agree to reimburse Advantage Golf Cars SEFL LLC for such unrecovered costs, including but not limited to deductibles and any uninsured losses.
2. I agree to hold harmless, defend and indemnify Advantage Golf Cars SEFL LLC, for any and all damages and claims of any nature whatsoever that may arise from the use of said golf car(s) during the time of the rental period, including but not limited to claims for damages to the golf car(s) itself, my person and property and the persons and property of others.
3. I agree to become familiar with the operation and use of said golf car(s), to read the "GOLF CAR INFORMATION SHEET" and any other instructions provided to me regarding the car(s), and to operate the golf car(s) in accordance with said instructions. I agree to contact Advantage Golf Cars SEFL LLC. If I have any questions or concerns about operating the golf car(s) or if my guest or I have caused any damage to the golf car(s) or others through the use of the golf car(s). I agree to examine and inspect the safety and mechanical condition of the golf car(s), reporting any concerns or problems before driving the vehicle(s).
4. I understand that a golf car is subject to the same laws and regulations pertaining to motor vehicles and therefore agree that the golf car(s) will be operated in accordance with the laws of the State of Florida including but not limited to the requirement that persons driving the golf car(s) must not be under the influence of alcohol and/or illegal drugs. I further agree that I personally will be responsible for all moving and/or parking violations, while under my control. I further agree that law prohibits me from using the golf car(s) on major interstates and highways.
5. I agree that only persons who are **16 years or older**, possess a valid driver's license and insurance as required by law shall be permitted to drive the golf car(s). I further agree to the maximum occupancy of the golf car(s).
6. I understand that if the golf car(s) should become inoperable through no fault of mine, Advantage Golf Cars SEFL LLC. will take reasonable steps to have the vehicle repaired. In the event the golf car(s) cannot be repaired or replaced, a refund will be issued towards the unused rental agreement period. If no incident is reported of the golf car(s) being inoperable while in my possession, **NO REFUND** will be issued.
