that if that was all she had on her then I would just write her a Ticket instead of taking her to jail. A "Ticket" is what the people in this area call a Notice To Appear and is common street terminology in this area. The Δ then reached in her left front pocket, and produced a long metal tube, with rubber on one end and wire mesh inside. The Δ also had a ball of copper wire mesh in her pocket. This is used as a filter for the crack pipe. I asked the Δ if she was still smoking "rock". The Δ said that she smoked crack cocaine approx. 2 hours before.

"Based upon my experience as a law enforcement officer, I recognize this paraphernalia to be used in common practice with drug related items. From its contents, appearance and/or, I believe this item has been used for illegal drug consumption."

The Crack pipe & wire mesh was placed in evidence.

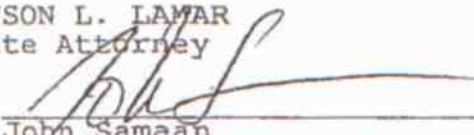

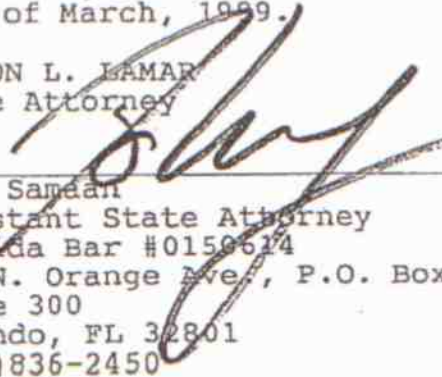

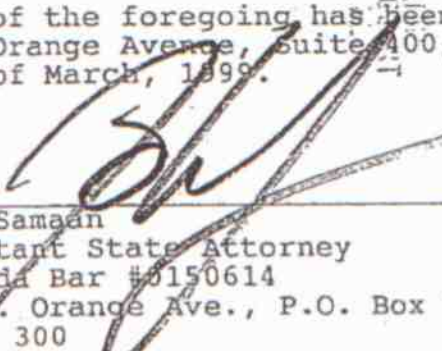
