The crime scene area is a combined commercial/residential area. A canvas of the neighborhood on the night of the crime produced minimal results. The vast majority of those contacted either were not home or were unwilling to speak to the police. Of those who did speak to the police, most saw or heard nothing.

A canvas of the commercial establishments also produced negative results. The police did not discover any security videos of the actual crime or its immediate aftermath.

Tonight, you are receiving a number of police reports. These reports consist of witness statements, a physical report on the livery cab and a summary of the initial ballistics, fingerprint and pattern investigations.

Finally, you have been advised that Mr. Cruz, although still in critical condition, is now expected to survive. Although Cruz is heavily sedated, his doctors indicate that he is able to communicate and is willing to cooperate in your investigation.

I was watching T.V. when I heard 2 gunshots close to each other. I looked out the window and saw a 4 door Livery cab on River Ave and 157st. I saw the rear passenger door open as the cab was trying to leave. I saw a male black jump out of the rear door and fall to the ground. The cab kept going on River Ave and the male black calmly put a large black gun in a brown bag and walked eastbound on 157st towards Gerard Ave. I then saw a lot of Police show up down on River Ave.
- Mr. **Leonard** described the passenger as a Male/Black/Well-built/5-30yrs old/shaved head/ with a White T-shirt tucked in his pants.
