requier that the use of the badge
that appear to be lawfully distinguish him
as a public servant to find him guilty
of criminal impersonation under subsection 4
comparing ~~this~~ Gaudalope situation with
the fact of

Buck when he lawfully held out his badge and introduced himself as a public servant, it similar to Guadalupe situation, citation. Therefore, Buck is likely ~~to be~~ guilty of criminal impersonation under subsection 4, citation.

Even if Buck would argue that he ~~is not~~ guilty of criminal impersonation because the state inspector ~~did not~~ whether the state inspector is a public servant or not, Supreme Court in state of Conn in State of Conn v Grorgio define a public servant as "is an officer or employee of government, elected or appointed, and any person participating as an advisor, consultant otherwise,

paid or unpaid, in performing a governmental function." citation. Which apply to Buck situation when he identifies himself as state inspector during the party, and during his arrest to Linda West and Marks, is ~~clear~~ ~~not~~ obvious to include a ~~paid~~ state inspector under the definition of a supreme court of Conn to a public servant, therefore he is most likely to be guilty of criminal impersonation under subsection 4. citation.
